	• The 2022 Spring Turkey harvest totaled 37,266 birds. Hunters had a 17% Success rate.
	• The Fall bonus authorization permit numbers were dropped to reflect the actual use numbers.
	• Public comments posed were on the low cost for out of state licenses, Higher sightings of turkeys in the north, disapproval for the later start of the turkey season and concern for the declining turkey population.
	· Pheasant survey numbers of wild population is up slightly
