**Project Description Summary**  
 Lincoln County is seeking maintenance funding for an additional 2.6 miles of winter ATV trail. The trail segment being applied for is currently a non-funded club trail that connects two existing funded trails. The trail is a vital connector that provides access to the city of Merrill. Since the trail segment is already being used as a club trail there will be no development costs. This trail segment is open to snowmobile use. Lincoln County winter ATV trails are not opened until one week after the corresponding snowmobile trail has been opened and trails are closed to ATVs when the temp is above 28 degrees F. UTV's are not allowed on winter ATV trails in Lincoln County. Lincoln County will maintain funded trails or assign maintenance activities on funded trails to another representative. Trails will be maintained by grooming, brushing, signing, grading, and performing other approved activities.

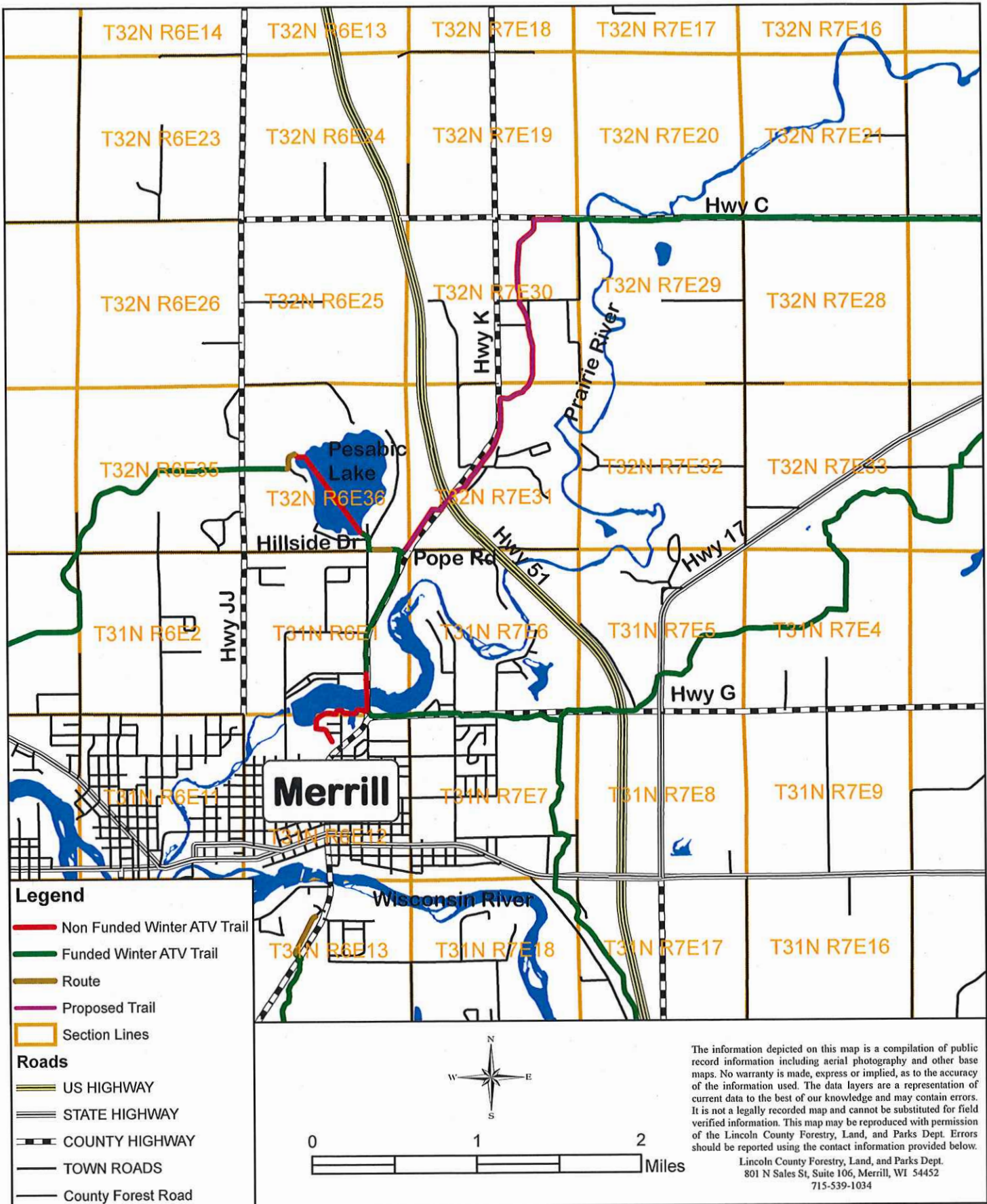

## 51N Trail 2.6 New Winter ATV Miles

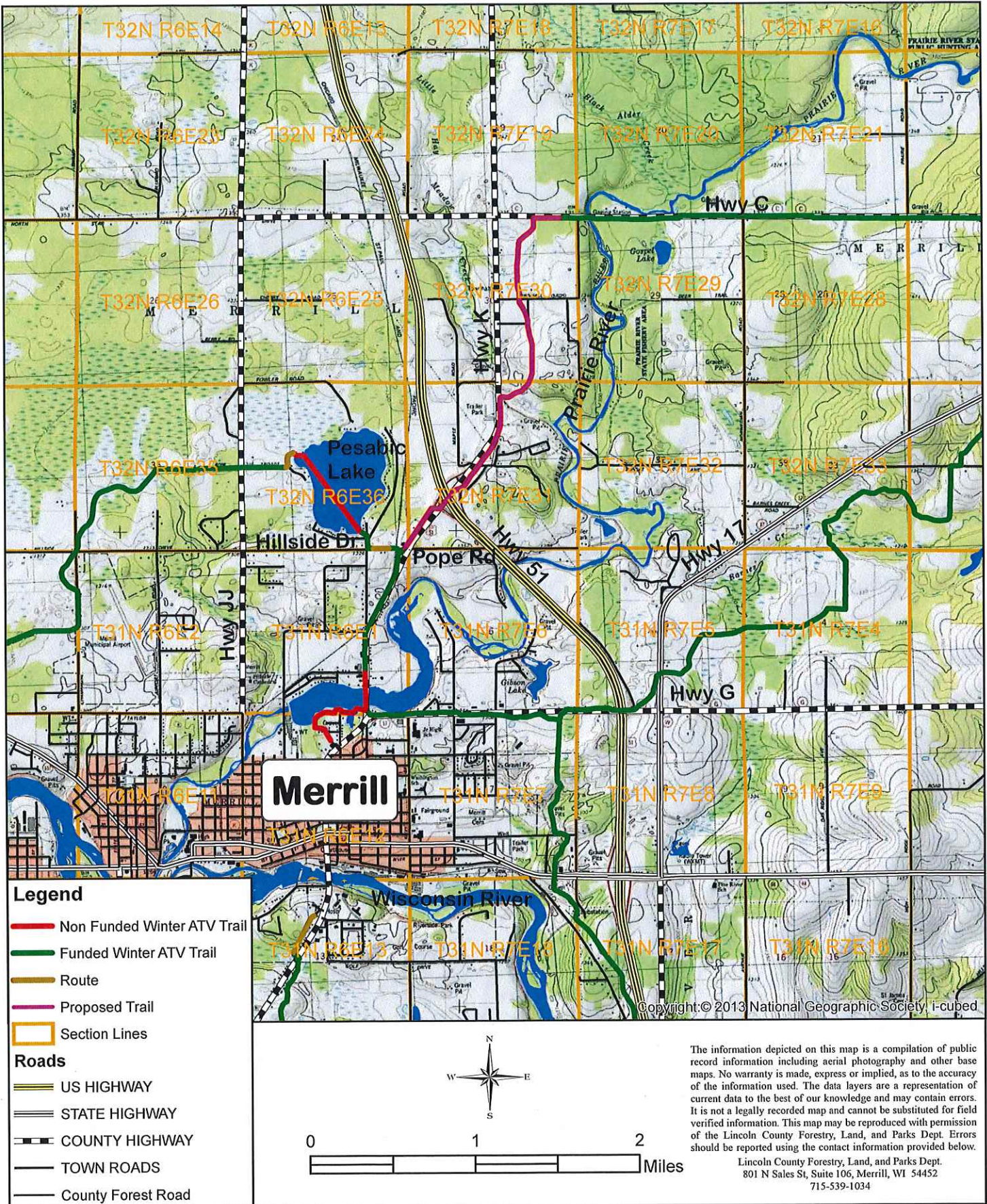

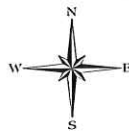

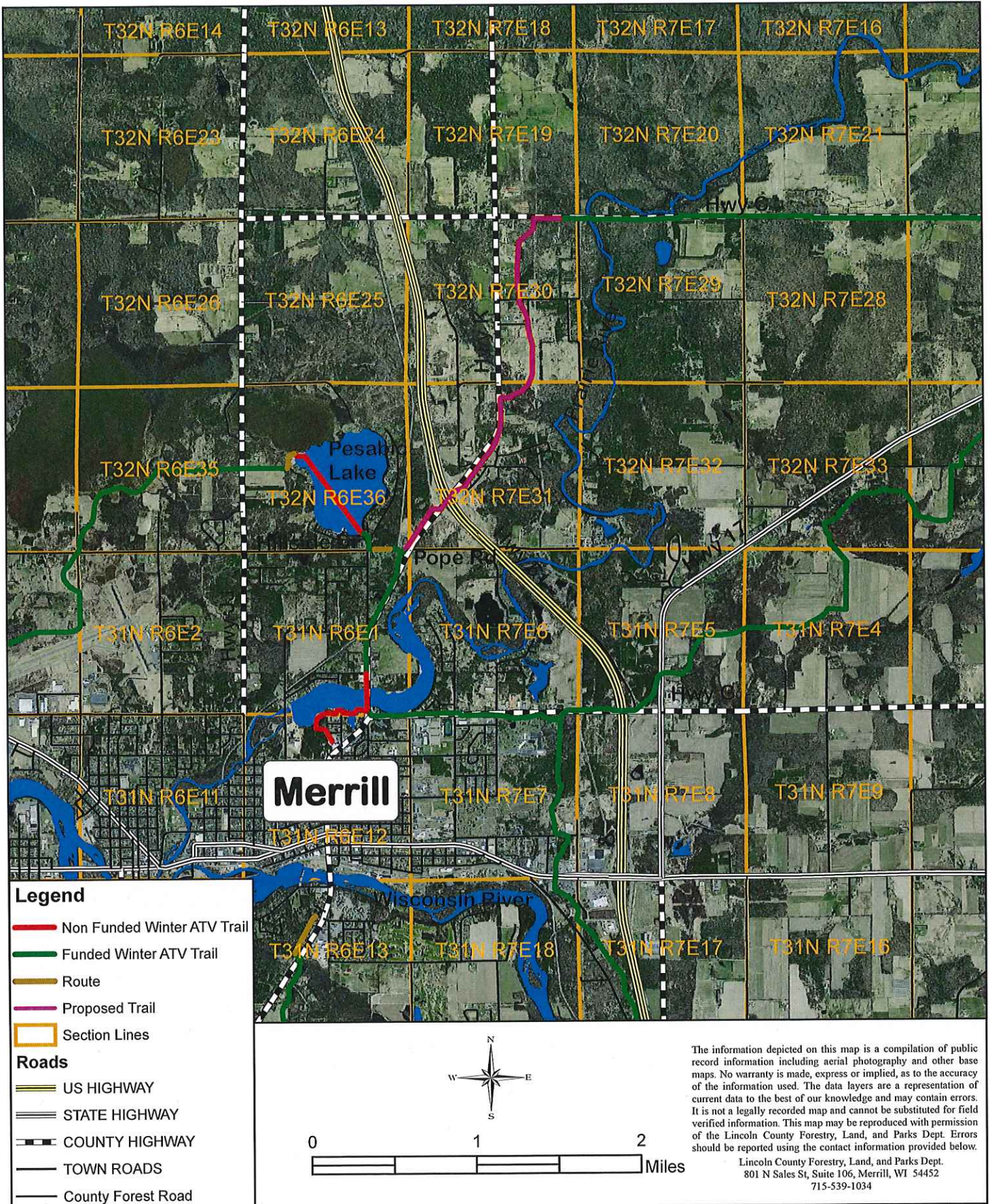
