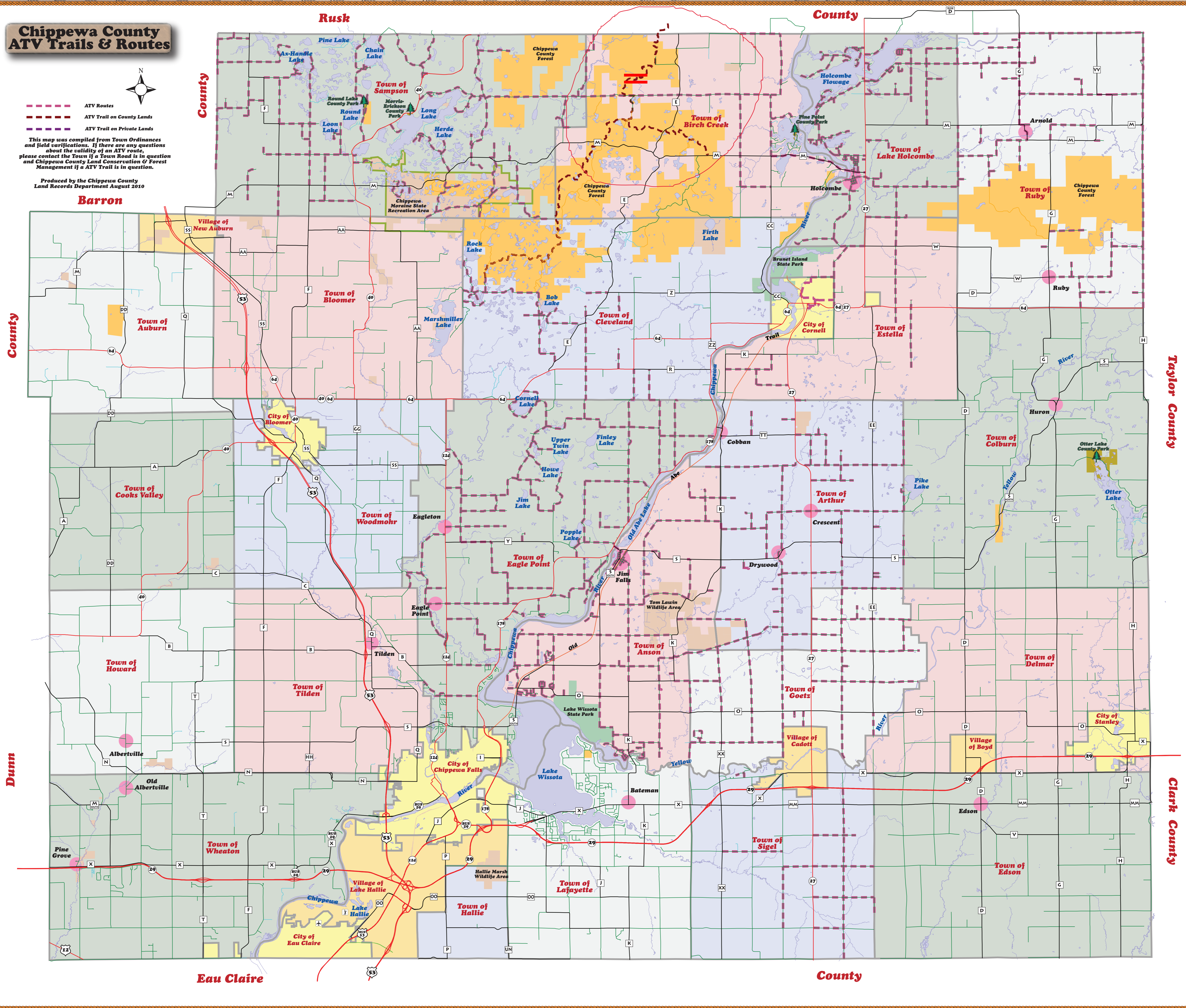
Chippewa County ATV Trails & Routes
