# Polk County, Wisconsin Snowmobile Trails



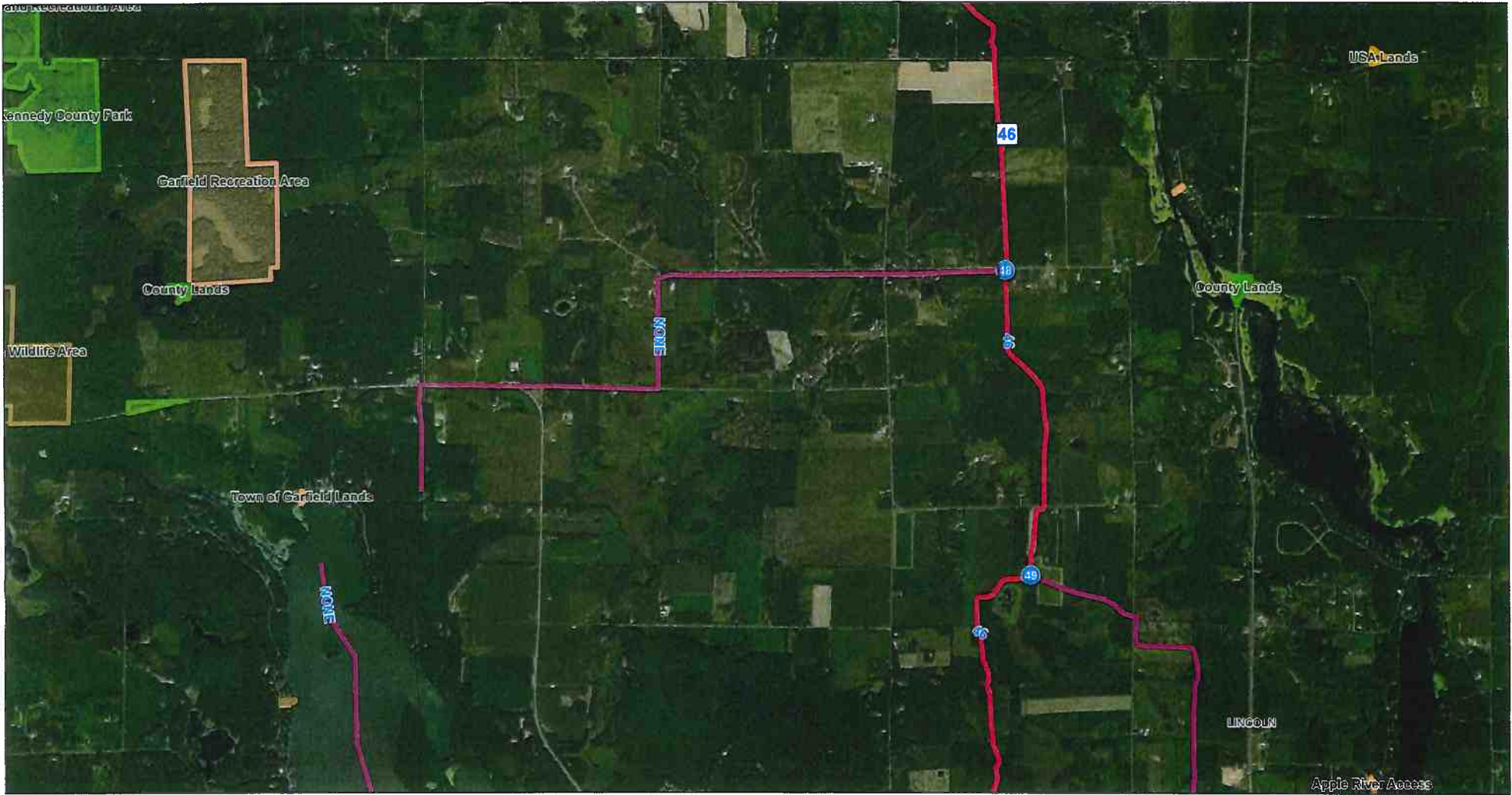

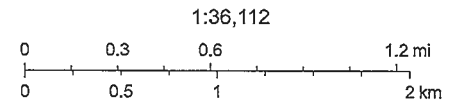
