Bidding Guidance

If a municipality is receiving financial assistance from the Clean Water Fund Program (CWFP) or Safe Drinking Water Loan Program (SDWLP), municipal officials and their prime contractors and subcontractors must comply with applicable state and federal procurement, bidding, and contracting laws. In addition, some municipal ordinances may have competitive bidding requirements.

Failure to comply with the laws/requirements may result in disbursements being withheld, a proportion of the project not being funded or being funded at the market interest rate, or the entire project not being funded. The DNR strongly recommends municipalities consult with their attorneys to ensure compliance with applicable laws when soliciting bids for contracts and procuring equipment, materials, and supplies for construction projects.

Prior to bidding

Prior to bidding a CWFP or SDWLP project, the municipality should obtain the necessary approvals for any engineering reports, selected sites, facility plans, and plans & specifications from the appropriate DNR bureaus. Addenda to the plans & specifications should also be submitted to the department for review prior to bidding if any changes impact the design that was approved. If construction begins before plans are approved, those costs may be deemed ineligible.

Bid advertisement requirements

Solicitations should clearly set forth all requirements that the bidder should fulfill. Examples of a Class 1 Public Notice and a Class 2 Notice (Advertisement for Bids) are in the Procurement Guide. To document compliance with procurement guidelines, obtain proof of printing in the form of an Affidavit of Publication from the publisher and store this with the financial assistance records.

Federal requirements

Municipalities must ensure that bid solicitations and resulting contracts and subcontracts contain the following language: Davis-Bacon, Disadvantaged Business Enterprise, and American Iron and Steel.

Required documentation

Before awarding financial assistance for any project, the DNR loans project manager must complete a bid review based on the submission of the required documentation listed in Bids and Construction Contracts.

Procurement Guide

The department prepared a plain-English Procurement Guide for Local Governments Receiving Grants (State or Federal) from DNR. Although this document focuses on grant recipients, much of the information provided also applies to CWFP and SDWLP loan recipients. Note that construction projects cannot be divided into smaller contracts to avoid bidding. Disclaimer: This guide is not a comprehensive review of all bidding law requirements. Consult your municipal attorney with detailed questions about compliance with bidding laws.

If the estimated cost of "public construction" is between \$5,000 and \$25,000, Wisconsin Statutes require that each municipality issue a Class 1 Public Notice concerning the proposed project before a contract is executed.

In general, municipalities are required by state law to comply with competitive bidding procedures when the estimated cost of "public construction" exceeds \$25,000.

Contract Compliance

The CWFP and SDWLP applicants are required to comply with federal requirements because the programs are funded with federal money.

If you are a construction contractor with a federal contract or subcontract, there are specific reporting requirements and regulations that apply to you.

The US Department of Labor's Office of Federal Contract Compliance Programs (OFCCP) website has the laws and policies as well as compliance assistance and resources for contractors at www.dol.gov/agencies/ofccp.

Ineligible contractors

The OFCCP enforces compliance to those laws and regulations specific to construction work. Entities and individuals may be suspended, debarred, or both for violating them. Such companies and individuals are declared ineligible to receive federal contracts and are excluded from federal procurement and non-procurement programs throughout the U.S.

The Wisconsin Department of Transportation prepares and issues a list of debarred, suspended, and ineligible contractors—causes include: failure to pay invoices, payroll problems, lack of business integrity and responsibility, failure to pay straight time, failure to pay overtime, and kickback—at wisconsindot.gov/hccidocs/debar.pdf.
