

PUBLIC NOTICE FOR DNR and EPA FIVE-YEAR REVIEW OF THE STOUGHTON CITY LANDFILL
SUPERFUND SITE

The Wisconsin Department of Natural Resources (DNR) and U. S. Environmental Protection Agency (EPA) complete a review every five years for the Stoughton City Landfill Superfund Site (the Site) located at the corner of Amundson Pkwy and Skogdalen Dr in Stoughton, WI.

The federal Superfund law requires the DNR and U.S. EPA to provide the public an opportunity to comment about the Site and the on-going cleanup process. The DNR and U.S. EPA conduct this review to make sure the remedy remains effective. This is the fifth such review since remediation work was completed in 1998. The last five-year review was completed in 2018.

The city of Stoughton began using the Site in the 1950s to dispose of commercial and municipal waste materials. Uniroyal, Inc. also disposed of solvents and other liquid chemicals at the Site. Groundwater sampling in 1984 revealed the need for additional investigation due to the presence of volatile organic compounds.

In 1991, the city of Stoughton agreed to complete remedial actions at the Site, including waste consolidation, landfill capping, fencing and land use restrictions. The 1996 Record of Decision provided additional protections to limit the release of contamination to the environment. By 1998, cleanup work was completed and long-term monitoring began, which continues today.

Today, the 27-acre Site exists mostly as a fenced and grass-covered field. The city of Stoughton maintains the landfill cap and fencing to provide protection from direct contact to waste material. Groundwater wells are monitored routinely to evaluate contaminant migration. Federal, state and county ordinances restrict groundwater use in the immediate area, which provides public protection from contamination that remains in groundwater.
