SPECIAL SALE CONDITIONS:

Approximately 115 acres of this sale are in the Flambeau River Scenic Management Area; operations within this area shall only be conducted during leaf-off (October 15th – March 31st).

For areas north of Lincoln Dr and east of Dog Patch Rd (41 acres), operations shall only be conducted between August 10th and March 31st to protect an endangered resource.

Due to the current density and distribution of regeneration within the purple group areas, harvesting equipment shall modify operations to prevent damage to the existing regeneration. If damage to regeneration exceeds 50% as determined by DNR contract administrator, equipment modifications shall be made.

Harvesting in the Pine Shelterwood Area shall only begin after scarification is completed by DNR forestry staff. Contractor shall notify DNR contract administrator by August of the year prior to harvesting and cutting shall be completed within 1 year of scarification.

Any woods trails that are used to facilitate hauling of wood shall have a debris berm placed on them adjacent to the town road per bid prospectus prior to sale completion. All woods trails and access points shall be leveled, re-ditched if necessary, and returned to their pre-sale condition.

No decking or skidding of wood allowed on town roads without prior approval from the Town of Draper. If decking on roads, all slash and ends shall be removed from the town roads and ditches concurrently with each truckload to minimize logging debris on the road. All slash located within 100 feet of Dog Patch Rd, Lincoln Dr, Snuss Blvd, and the ATV/snowmobile trail shall be lopped and scattered to within 2 feet of the ground.

No decking of wood allowed on the snowmobile trail; 3 inches of packed snow will be maintained on trail, weather permitting; only 1 crossing allowed on the trail.

All additional restrictions listed in prospectus and standard contract apply unless specified.
